3. TYPE OF PROCUREMENT PROCEDURE

Simple procurement procedure of services: JN 60-2025

Based on Article 15 of the Public Procurement Act (Official Gazette No. 120/16 and 114/22) for an estimated value of less than EUR 26.540,00 without VAT for goods and services, or EUR 66.360,00 without VAT for works (the so-called simple procurement), the public contracting authority, Croatian Academy of Sciences and Arts is not obliged to carry out the public procurement.

4. SUBJECT OF THE PROCUREMENT PROCEDURE

- **4.1. Subject of the procurement procedure**: Geophysical Prospection at the Roman site of Mursa
- 4.2. Estimated value of the procurement: 11.000,00 EUR without VAT
- 4.3. CPV mark and name: 71351720, Geophysical Prospection at the Roman site of Mursa
- **4.4. Quantity of procurement items**: The quantities of procurement items stated in the Cost Sheet form, which is an integral part of this Call for Tender are exact.

4.5. Cost Sheet

The Cost Sheet in a non-standardized form can be found in Attachment 2 and is an integral part of this Call for Tenders. The bidder must fill in the requested unit price and the total price without VAT of the Cost Sheet on the prescribed form.

The unit price of an item of the Cost Sheet may be expressed with a maximum of 2 (two) decimal places.

Bidders may not change the Cost Sheet (add items, add additional units of measure, change quantities or add notes).

4.7. Description of the subject of procurement

The procurement concerns geophysical surveying using GPR over an area of 1 hectare in the eastern part of the University Campus in Osijek. The survey must be conducted urgently, ideally within 2 days, preferably over a weekend when the area is not used as a parking lot. A contractor with a large-scale four-channel GPR system (with a 250 MHz central frequency and 0.4 m antenna spacing) is required. Due to the complexity of processing large data volumes, the contractor must have appropriate IT infrastructure, software solutions, and sufficient expert staff to process and interpret the data within 30 days.

4.8. Technical specification

The subject of this simple procurement procedure is geophysical surveying using Ground Penetrating Radar (GPR) over an area of 1 hectare in the eastern part of the University Campus in Osijek. The survey needs to be conducted as soon as possible, and no later than within three days after contract signing, preferably over a weekend when the area is not used as a parking lot. The survey aims to gain insight into underground structures using non-invasive methods. The results will later be verified through targeted archaeological excavations during 2025 and 2026. This evaluation aims to assess the available GPR technology for the Osijek area. The survey area will include various surfaces: lawns without prior interventions, lawns used as construction material depots, and asphalted and concreted surfaces (parking lots). The contractor must possess the technical equipment and staff capable of surveying the defined area within the prescribed timeframe, processing the data and producing the report within 30 days. Previous experience surveying Roman urban sites within modern settlements is particularly valued, preferably in the Osijek area.

The contractor must have a large-scale GPR system with four channels, transmitting and receiving antennas with a central frequency of 250 MHz.

The distance between antennas should be 0.4 meters.

The expected average wave velocity is 0.1 m/ns, which, considering the two-way travel time, results in a scheduled penetration depth of approximately 0.25 meters in 5 ns. Due to the complexity of processing large volumes of data, the contractor must provide adequate IT infrastructure, appropriate software solutions, and sufficient expert staff for timely data processing and interpretation.

4.10. Deadline for delivery/execution of the subject of purchase:

2 days for surveying / 30 days for data processing and report preparation.

5. CRITERIA FOR SELECTING AN ECONOMIC ENTITY (GROUNDS FOR EXCLUSION AND CONDITIONS OF ABILITY)

The contracting authority shall reject the bid of a bidder who does not meet the condition of impunity, settled tax liabilities, and the ability to perform professional activities.

For this purpose, bidders are obliged to provide evidence of the non-existence of:

Grounds for exclusion of an economic operator:

- 1. A statement of no criminal record provided by a person authorized to represent (**Attachment 3**), which is an integral part of this Call for Tender.
- 2. Statement on the absence of tax debt (**Attachment 4**), which is an integral part of this Call for Tender.

Evidence of ability

3. Statement of registration for the performance of professional activity on the form (**Attachment 5**) which is an integral part of this Call for Tender.

6. CONTENT AND METHOD OF MAKING THE OFFER

When making an offer, the bidder must comply with all requirements and conditions from this Call. The Contracting Authority will not accept an offer that does not meet the requirements and conditions related to the subject of procurement in this Call.

Alternative offers (offer variants) are not allowed.

The offer is made in Croatian or English and in the Latin script, using only the proposed forms (attachments) from this Call.

All other documentations attached to the offer must be in Croatian or English. All documents that are not written in Croatian or English must be translated into Croatian or English.

Exceptionally, it is possible to list certain words, names, concepts, etc. In a foreign language and use an internationally recognized expression, i.e. the so-called internationalisms, other people's words and adaptations, which do not affect the comprehensibility of the offer.

The bidder will submit its bid on the form (Attachment 1), which is an integral part of this Call for Bids with the required attachments (2,3,4,5), to the following e-mail address: <a href="mailto:pdoto:p

The deadline for the delivery of offer: May 8, 2025, by 12:00 p.m.

The bidder submits a bid with a price expressed in euros, excluding value added tax. The price of the offer is written in numbers.

The price of the bid is expressed for the entire subject of procurement based on the Cost Sheet. The price of the offer includes all costs and discounts without VAT.

The offer shall be submitted either in Croatian or English.

The Contracting Authority will conduct the opening of offers after the deadline for the submission of offer has expired.

The opening and review of offers will be carried out by members of the Contracting Authority's expert committee.

The opening of offer is not public.

7. OFFER VALIDITY PERIOD

The validity period of the offer is at least thirty days (30) from the expiration of the deadline for the delivery of offers.

The offer is binding on the bidder until the offer expires, and at the request of the Contracting Authority, the bidder can extend the offer's validity period.

8. CRITERIA FOR SELECTING THE OFFER

The criterion for selecting the offer is the lowest price with the obligation to fulfil all conditions and requirements of this Call and its attachments. If two or more valid offers are equally ranked according to the offer selection criteria, the Contracting Authority will choose the offer that was received earlier.

9. SELECTION OF OFFERS

The Contracting Authority will deliver the Notice on the selection or cancellation of the procurement procedure no later than 30 days after the expiration of the deadline for the submission of offers.

10. CONTRACTING METHOD

The Contracting Authority will conclude the written contract or deliver an order form.

11. DEADLINE, METHOD AND TERMS OF PAYMENT

Payment will be made based on a valid electronic invoice that contains all the necessary legal elements, to the IBAN account of the selected bidder, within 30 days from the date of receipt of the correct invoice.

The invoice is submitted for payment electronically, in accordance with Directive 2014/55/EU of the European Parliament and the Council and Croatian legislation, according to which the Contracting Authority is obliged to receive and process only electronic invoices from July 1, 2019.

12. APPEALS

Appeals are not allowed on the simple procurement procedure or on the selection of the bidder.
